WHEN A PATIENT IS ADMITTED TO THE MARICOPA MEDICAL CENTER ARIZONA BURN CENTER, ONE OF THE FOUNDATION'S STAFF MEMBERS IS THERE TO IMMEDIATELY OFFER SUPPORT TO THE FAMILY. ARIZONA BURN FOUNDATION ASSESSES THE NEEDS OF THE BURN SURVIVOR AND THEIR FAMILY AND CREATES A CARE PLAN APPROPRIATE FOR THEM. THE FOUNDATION MAY PROVIDE DURABLE MEDICAL EQUIPMENT, PRESCRIPTION PAYMENT, OR FINANCIAL ASSISTANCE WITH RENT, UTILITIES OR FOOD IF THIS NEED IS NOT MET BY OTHER MEANS.
